OFFICIAL RULES

SPONSOR:

CONDUCT:

This Sweepstakes is governed by these official rules ("Official Rules"). By entering this Sweepstakes, entrants agree to be bound by these Official Rules, and the decisions of the Sponsor shall be final and binding in all respects. The Official Rules will be posted in all Seasons Corner Market stores and on the following website throughout the Sweepstakes Period: <https://www.seasonscornermarket.com> (the "Seasons Corner Market Website"). Failure to comply with these Official Rules may result in disqualification. The Sponsor reserves the right at its sole discretion to disqualify any individual found to be tampering with the entry process or the operation of the Sweepstakes via The Seasons Corner Market Website, the Seasons Corner Market App or the Guest Rewards Program; or to be acting in any manner deemed by the Sponsor to be in violation of the Official Rules; or to be acting in any manner deemed by the Sponsor to be unsportsmanlike or disruptive, or with intent to annoy, abuse, threaten or harass any other person or with intent to affect the outcome of the Sweepstakes.

ELIGIBILITY:

NO PURCHASE NECESSARY TO ENTER THE SWEEPSTAKES OR WIN THE PRIZE. The Sponsor reserves the right to extend, shorten, or alter the Sweepstakes Period in its sole discretion.
